
Who we are

Two Walks in L17 – From the Park to the River

In May, MCS organised Two Walks in L17 – From the Park to the River, led by Dr Kay Flavell, Author of *People of the Lane: Growing up in and around Lark Lane 1880-2020.* Now living in California, Kay lived on Lark Lane during the 1980's and recorded an oral history of the street by interviewing local residents and traders. The two walks attracted 52 bookings.

Docklands Trail Centre and Stanley Dock

On September 21, an MCS visit to the Dockland Trail Centre in Collingwood Dock was arranged followed by a guided tour of Stanley Dock by Heritage Consultant, John Hinchliffe. Attendees donned hard hats for a look round the, as yet unrestored, South Warehouse, the partially restored Tobacco Warehouse and the fully restored North Warehouse, now the Titanic Hotel.

Prescot Heritage Trail and Shakespeare North Playhouse

Our final visit this autumn was to Knowsley's brand new Cockpit Theatre on October 20, together with a Blue Badge Guide-led walk around Prescot Heritage Trail. The 20 guests who attended also enjoyed a pre-theatre menu at Pinion and a performance of A Midsummer Night's Dream.

Campaigning

Save the Piazza Fountain

We continued our major campaign from 2021 to raise funds for a feasibility study for the comprehensive restoration of the Piazza Fountain in Drury Lane. Funding for both phases of the study was achieved. Following completion of the first phase of the study, there are ongoing discussions about phase two and with Liverpool City Council and the leaseholder, The Elliot Group. Gateacre Heritage Sleuths

In Autumn 2021, Historic England approached MCS to be part of a national pilot re enriching the National Heritage List for England. We selected Gateacre as the focus of our study area and recruited 13 volunteers to survey, photograph and record any changes to Listed Buildings in the study area, compared to the original listings. MCS project managed the pilot and volunteers and continues to work with the Gateacre Society to produce a new microsite about Gateacre's Heritage. Planning, Campaigns & Policy Group

MCS reviews and responds to planning issues and activities within Liverpool and the wider city region. We encourage public engagement with on-going debate and aim to draw together diverse voices from our member communities and make a positive contribution to discussion that have an effect on the quality of life for us all. The Planning, Campaigns & Policy Group has met four times this year and brings together professional experience and community engagement



In the course of 2021/22 the group has engaged with a number of topical issues:

- Meeting with Liverpool City Council Planning and Conservation teams (April)
- Represented MCS at the World Heritage UK World Heritage Lost Conference on 23 June and produced a bold initiative recommending the establishment of National Heritage Areas: Seizing the Moment https://www.merseysidecivicsociety. org/wp-content/uploads/2022/08/Seizing-the-Moment.pdf
- Produced two policy documents on Conservation Areas and Listed Buildings
- Supported the Mossley Hill Residents
 Association on achieving the successful Listing
 of Bark Hill House which resulted in a change
 of plans for the site by LJMU
- Commented on Planning Applications by Leverhulme Estates for Wirral Green Belt housing, Bonded Tea Warehouse, and the Former Central Hydraulic Tower in Wirral Waters
- Responded to Wirral Local Plan
- Responded to consultation on the Liverpool City Council Tall Buildings Policy
- Responded to consultation on the Liverpool City Regional Transport Plan Vision and Active Travel Schemes
- Is in the process of setting up a community partners working group for the Bicentenary of Liverpool – Manchester Railway
